**Completed COP-RCORP Consortium Work on RCORP-Implementation Core Activities:**

**Prevention #2a** – Provide and assess the impact of culturally and linguistically appropriate education to improve family members’, caregivers’, and the public’s understanding of evidence-based treatments and prevention strategies for SUD/ODD and to eliminate stigma associated with the disease. Operationalized with Master Consortium Position Statement on CLAS standards. (Will be revisited periodically).
